Our Team's Goals

Improve Management, Planning, and Communication Among Delegates: Our delegates are our ground force, but we need a more structured approach to keeping our team informed, engaged, and prepared to act. We'll develop clear communication channels and provide better planning resources so everyone is on the same page.

Cultivate and Support Candidates for Local Office: Winning starts with recruiting strong candidates, especially for county council, where we must be more competitive. We need to actively identify, mentor, and support Republicans who are willing to run and ensure they have

the tools they need to succeed. There will be no free rides for Democrats, every seat will be contested.

Strengthen Relationships with GOP Elected Officials in our Cities and Towns: Republicans already hold positions in city councils and mayoral offices across Summit County, but we need to foster stronger ties with them. Their perspectives and leadership are vital to our overall strategy, and we should be working together, not operating in silos.

Make It Easier for Precinct Chairs to Engage During Election Cycles: Precinct chairs play a crucial role in grassroots efforts, but they often lack the support they need. We'll develop easy-to-use resources and a structured systems so they can be more effective in organizing their precincts.

Develop a GOP Playbook for Election Season: Every cycle, we need to start strong and organized. We'll build a comprehensive, reusable playbook for county races that outlines exactly how we run elections, covering outreach, messaging, fundraising, and volunteer mobilization—so we're not reinventing the wheel each time.

Engage the Public and the Press to Advance GOP Values: Currently, we are letting our opponents define us. We have got to do a better job telling our story and making the case for conservative leadership in Summit County. That means strategic media engagement, op-eds, community events, and direct outreach to voters to clearly articulate our priorities.

Dramatically Improve Fundraising: To compete, we need the resources to support candidates, expand outreach, and strengthen our organization. We will develop a targeted fundraising strategy that engages both grassroots donors and major supporters to ensure we have the financial backing to succeed.
